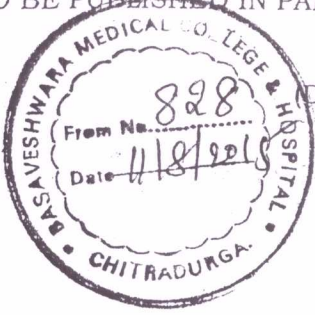

NOTIFICATION

S.O..... In exercise of the powers conferred by sub-section(2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, namely:-

In the said Schedule -

a) against "Manipal University, Karnataka" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

(This shall be a recognised medical qualification when granted by Manipal University, Karnataka in respect of students being trained at Kasturba Medical College, Mangalore, Karnataka on or after 2014).

b) against "Sri Siddhartha University, Tumkur, Karnataka" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine (Dermatology, Venereology & Leprosy)"

c) against "KLE University (Deemed University), Belgaum, Karnataka" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

“Doctor of Medicine (Paediatrics)”

(This shall be a recognised medical qualification when granted by Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka in respect of the students being trained at ESI-PGIMSR, ESI-Hospital, Rajajinagar, Bangalore, Karnataka on or after 2014).

“Doctor of Medicine (Anaesthesiology)”

MD(Anaesthesiology)

(This shall be a recognised medical qualification when granted by Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka in respect of the students being trained at ESI-PGIMSR, ESI-Hospital, Rajajinagar, Bangalore, Karnataka on or after 2014).

- Note to all: 1. The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
2. Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
